North Carolina Needs a New Statewide Site Readiness Strategy

PROBLEM



Despite the wins, the losses are mounting.

North Carolina's success is no secret. Continually ranking at the top of lists for business, interest in locating here is at an all-time high. Taxes are friendly, regulations are measured, and North Carolina has much to offer for quality of life.

However, demand for product far outpaces available sites.

EDPNC recorded 292 business recruitment projects in 2021. In 2022, that number jumped to 316.

Site Size

- Of the 202 real estate requests, 46% desired a site, 37% wanted a building, and 17% were open to a building or site.
- 83% of the real estate requests desired no more than 200,000 sq/ft.
- 84% of the site or site/building requests were for no more than 250 acres; 69% requested no more than 100 acres.*

Project Losses

• Of the 67 reported project losses in 2022, 55% were due to a lack of suitable building/site. This is up from 42% in 2021.*

SOLUTION

For sites under 1,000 acres, **NCEDA proposes a \$100 million revolving fund for product development**. This program would competitively and regionally award applicants in several categories: site analysis, preparation, and acquisition. Applications will be evaluated on numerous criteria, including local participation and economic impact.

This program would allow all 100 counties to participate, and locals would be responsible for returning the zero-interest awards either at the sale of the site or within 5 years, except for site analysis grants.

Megaprojects are headline grabbing, but your community thrives on the smaller successes that do not receive a statewide announcement, and our competitors are making these kinds of investments in their states' communities.

NCEDA's proposal would keep North Carolina in the game on more projects where we do not have sufficient product, and its revolving nature would continue to support growth across the state to produce additional economic opportunity.

STATUS

The House SelectSite Provision aims at 10 new sites for state support that can provide 1,000 new jobs.

Only a few counties could support an immediate one-project, 1,000-person increase in workforce demand. Most communities would prefer product development aid that would lead to the attraction or expansion of 10 companies that generate 100 new jobs each, which builds a diverse tax-base and more resilient local economy. NCEDA's proposal would prevent a scenario like Canton.

The **Senate** budget proposal seeks to study sites less than 1,000 acres for future consideration of state support.

• While it can be beneficial to understand the product in need of further development, most communities have a strategic plan for the sites they have under public control or are seeking to obtain. A competitively award, scrutinized program would accomplish the conservative goals of the Senate while enhancing the likelihood that rural communities can win projects without losing another year.

CALL TO ACTION

House and Senate Conferees will soon be named and begin the final stage of the budget process in the coming days.

- Explain the need for smaller site support, where 1,000 jobs should not be the goal

- Explain the need for resources NOW, not in a year or two after unnecessary research is completed.
